Season pass holders pay only \$45 with cart after 12 pm (\$35 at Wallingford for Dual Pass holders) on Weekends and Holidays when tee times are available. Season pass is valid from April 2, 2012 to November 16, 2012. Regular greens fees apply during times not specified on your season pass. Tee times are on a first come first serve basis and can be booked 10 days in advance, 3 days earlier than non pass holders. The Cart fees for 2012 will be \$16 plus tax for 18 holes and \$9 plus tax for 9 holes.
